Founded in 2001, KOFF is a dialogue and exchange network facilitated by swisspeace connecting Swiss state and non-state actors active in peacebuilding. Its mission is to ensure that Swiss peacebuilding activities are strengthened, relevant, and visible.

To do so, KOFF facilitates dialogue and learning processes in Switzerland and abroad and fosters information sharing with a view to develop strategic alternatives, policy recommendations and joint initiatives for peace with its member organizations.

## **Editorial**

In many respects, the events of 2015 have had a significant impact on KOFF, which is approaching its 15th anniversary. At national level, the Swiss Federal Department of Foreign Affairs (FDFA) presented its new Dispatch on Switzerland's International Cooperation 2017-2020, which is due to be discussed and approved in Parliament in 2016. Meanwhile, various key milestones were also reached on an international scale with the 2030 Agenda for Sustainable Development and the review of the United Nations' peace and security architecture. In addition, 2015 saw international conflicts creep closer and closer to Europe, causing much concern also in Switzerland. The fundamental question facing us now is how new challenges such as violent extremism or migration are fitting into peacebuilding and human rights work.

In this context, KOFF held three consultation meetings with its member organizations in Bern, Zurich and Geneva as part of its strategy process. It was evident from the discussions that peacebuilding and human rights work, as well as working in fragile contexts, are still of crucial importance. It also became clear that members need a platform for dialogue and would like to see KOFF to play a stronger political role in Switzerland.

Due to government budget cuts, KOFF will not be able to fully implement its new strategy in 2016. With this in mind, it will focus on its function as a platform and will no longer be offering training courses and free consultations for members. One new development, however, is the incorporation of KOFF into the new swisspeace topic area "Policy & Platform", making it possible to step up efforts to network with other platforms – such as, at international level, the European Peacebuilding Liaison Office (EPLO) or the Civil Society Platform for Peacebuilding and Statebuilding (CSPPS), of which KOFF is a member. The aim is also to use international and local platforms to create entry points for influencing policy and to enable findings from practice-oriented learning processes to be transposed for policy processes and integrated into them. Other initiatives which serve this purpose are the "Conflict Sensitivity Community-Hub" (CSC-Hub) set up by KOFF, which now counts 15 international NGOs amongst its members, and the learning process on the topic of "shrinking space for civil society" in Honduras, which has been initiated in cooperation with seven member organizations and their partners.

Aside from the launch of the CSC-Hub and learning processes in local contexts, in this annual report we want to draw attention to further highlights in 2015. These include the establishment of a parliamentary group on peacebuilding, the activities of the "Women Peace Security – reloaded" working group, which was founded by KOFF, on the limits and opportunities offered by the UN agenda on women, peace and security, and the roundtable series run in parallel with the election and peace processes in Myanmar.

The KOFF team has been consolidated this year and has managed to deal with the many changes it has faced in a constructive and creative way. We are confident that, despite the cutbacks, KOFF will assume an increasingly important role and raise relevant issues at both strategic and political level. On that note, we are looking forward to an eventful 2016!

## 1. Joint Learning Process in Honduras



In spring 2015, KOFF – on the initiative of its member organizations HEKS and Peace Watch Switzerland – kicked off a joint learning process on the topic of "space for civil society action in Honduras". This issue was a pressing one, since political, legal, economic and social developments in Honduras are making the work of local, national and international civil society organizations increasingly difficult. With this in mind, KOFF joined forces with five more Swiss NGOs and, with the support of the Swiss Agency for Development and Cooperation (SDC) in Honduras, set itself the following goals: to prepare a participatory and differentiated analysis of Honduran civil society and its space for action using a method developed by ACT Alliance, and to develop joint strategies for preserving and expanding this space.

In the course of this process, the immense scale of the challenges became clear: Honduran civil society is faced with a state that is going to greater and greater lengths to cut itself off from the concerns of sectors of society. To do this, it takes

advantage of legislation, corruption in the judicial and political systems, heavy surveillance, disinformation in the media and repression. The state is thus acting in the interests of national and transnational elites and is paving the way for implementing a neoliberal development model. What's more, this policy generates and condones extreme criminal violence, which is having an impact on everyday life and poses a serious risk to security. Although they are nothing new, these dynamics have intensified and gained momentum since the coup in 2009.

Social organizations are being overwhelmed by the profusion and pace of these developments. Although they are putting up resistance, they often remain reactive, focusing on defending sectoral rights and interests or even on simply safeguarding their existence. The result is a high degree of fragmentation amongst civil society organizations, which is further exacerbated by the competition surrounding funds for international cooperation. There is therefore no basis for building a common long-term strategic vision.

This is where the joint learning process is meant to come in. Yet for all the potential it offers, it also brings with it challenges of its own. While a joint analysis involving different perspectives undoubtedly creates a space for dialogue and mutual understanding, it also requires a certain degree of trust, which needs to be built up first through such spaces. Jointly developed strategies certainly benefit from synergies and from pooling the knowledge of various actors, but they will not be effective as long as the individual organizations involved are having to battle with existential threats that can only be tackled through these strategies.

As far as the Swiss organizations are concerned, however, one preliminary conclusion that can be drawn is that processes like these, which go beyond program implementation and promote collective and innovative approaches and synergies, are hugely important – specifically, as a way of providing positive impetus in a long-term process of transformation towards a fairer and more peaceful Honduras. KOFF will therefore continue to support such processes in future.

## 2. Strengthening KOFF's Political Role in Switzerland

In June 2015, the Swiss Federal Administration presented the first draft of the new Dispatch on Switzerland's International Cooperation 2017-2020 to civil society organizations across all fields. To ensure coherence, this Dispatch brings together five framework credits (SDC's regional cooperation, humanitarian aid and the global programs, SECO and the Human Security Division) in a single document for the first time. A wide variety of issues were therefore raised during the civil society consultation process. However, there proved to be little scope for more in-depth discussion on a range of topics from peacebuilding to fragility, despite the fact that Switzerland is keen to step up its engagement in conflict-affected and fragile contexts and it would be important not only to be aware of the tools and approaches available to Switzerland in various areas, but also to work together on applying these resources in a more strategic way.

KOFF and 22 of its member organizations therefore decided to issue a statement which emphasizes both the importance of strong peacebuilding and human rights work and the interconnectivity between areas (development cooperation, humanitarian aid, peace and security). Pinpointing the key interfaces between these areas could prove to be precisely where the new Dispatch demonstrates its innovative strength. For this interconnectivity to be put into practice, however, financial resources and basic structures would need

to be made available, as one joint document is not enough to ensure actual implementation. The statement also stresses the importance of cooperation with civil society and the security sector.

2015 also saw the establishment of a parliamentary

group on peacebuilding, with KOFF/swisspeace holding the secretariat and a committee made up of representatives from the FDP (The Liberals), the SP (Social Democratic Party), the GLP (Green Liberal Party) and the CVP (Christian Democratic People's Party) leading the group. This group provides a platform within the Swiss Parliament for highlighting specific issues relating to peacebuilding and the niche role Switzerland can play on the international stage and for bringing up risks and problems. The aim is to increase awareness amongst parliamentarians in order to raise the profile of peacebuilding as an instrument for foreign policy and to show how it fits into international cooperation in general. In 2016, the parliamentary group on peacebuilding will also be in contact with the existing bodies involved in development cooperation, the parliamentary group "Groupe Suisse – Solidarité Internationale" and the Advisory Committee on International Cooperation.

In 2016, KOFF would like to carry on the political discussion that has already been started with a wide range of actors from different areas, opening up various perspectives. After all, interaction between all partners concerned is essential for cultivating a coherent peace and development policy in Switzerland which is effective and relevant in local contexts.

## 3. "Women Peace Security - reloaded"

The FDFA's regional examples of how the Swiss National Action Plan to implement **UN Security Council Resolution 1325** (UNSCR 1325) is being put into practice are showing some encouraging results. In Africa's Great Lakes region, for example, women's organizations with support from Switzerland are taking action, despite attacks by UN soldiers on women and young people, to secure their environment and improve basic services. Nevertheless, conditions remain difficult, the situation is fragile and people are undergoing traumatic experiences. What's more, 15 years on from the signing of UNSCR 1325, doubts over its effectiveness have grown.

In 2015, the working group "Women Peace Security – reloaded", which was set up by KOFF and consists of Swiss feminist NGOs specialized in women's rights, explored the question of what long-term social and economic changes would be needed to transform the living conditions of these people in a more genderappropriate way. This also called for critical reflection on the limits of the UN agenda on women, peace and security and creating scope for a more gender-sensitive peace policy.

In connection with this, the working group organized three in-depth workshops on Syria, Bosnia and Herzegovina and Switzerland. The aim of these events was to analyze the discourses on conflicts, conflicting parties, humanitarian aid, peace negotiations and victims of war in order to gain an understanding of how they make use of gender differences and how they produce their effect. For instance, the working group wanted to know how security in Bosnia and Herzegovina has changed from the point of view of women today and what part civil society plays in this, how the various actors involved in the conflict in Syria attribute certain roles to men and women which go against the emancipatory intentions of the UN agenda, and – finally – what Swiss peace and security policy would have to look like in order to meet the requirements of a gender-sensitive approach.

The case study on the security of women in Bosnia and Herzegovina, for example, shed light on the failure of actors to see the UN agenda as a comprehensive, long-term project. Although war is now a thing of the past, discrimination against women from rural areas, the lack of a budget for benefits and everyday infrastructure, the high tolerance threshold for sexist discrimination, shortages in the regular labor market and increasing domestic violence are giving rise to social, political and economic insecurities amongst many women which are being obscured by a gender policy focused on war. These insecurities are being picked up by local civil society organizations, but they have limited space for action.

The findings from these discussions are also being incorporated into an alternative report on the Swiss National Action Plan 1325 aimed at NGOs, experts and state actors. This report, the first of its kind, is due to be presented to the public in the course of 2016 and is intended to highlight new opportunities for action to promote gender-sensitive peacebuilding.

## 4. Launch of the Conflict Sensitivity Community-Hub



Participants at the international expert retreat on conflict sensitivity organized by KOFF in autumn 2014 identified a kind of crisis in the area of conflict sensitivity: twenty years after insights were gained into the role of international engagement in the conflicts in Rwanda, Somalia and the Balkans, the need for conflict-sensitive working approaches may be generally acknowledged, but attempts to

implement them still tend to falter. Even in the crucial discourse on the effectiveness of development aid, scant consideration was given to conflict sensitivity, and it risked being overshadowed by new trends in international cooperation.

Together with over 20 international NGOs, think tanks, donor organizations and research institutes – the "conflict sensitivity community" – KOFF is keen to give conflict sensitivity fresh impetus and raise its profile. With this in mind, it instigated the establishment of the "Conflict Sensitivity Community-Hub" (CSC-Hub) in 2015. As a global nucleus for conflict sensitivity, this hub is designed to help organizations address this topic by joining forces and cooperating across sectors. The CSC-Hub aims to ensure that conflict sensitivity has a stronger presence in international and national development policy and is given the chance to make a greater impact in programs in the field. To this end, it focuses on the following areas of activity:

- Community of practice: mutual learning and exchanging analyses, information and resources relating to conflict sensitivity
- Synergies: networking within the community and promoting coordination and cooperation between local, national and international actors
- Raising awareness and accountability: developing quality standards for conflict sensitivity and raising awareness of accountability amongst actors involved across various sectors (including the private sector)
- Advocacy and policy dialogue: pooling and supporting existing initiatives and efforts aimed at embedding conflict sensitivity in discourses on development policy

This strategic focus of the CSC-Hub was determined on the basis of thorough consultations with national and international actors involved in peacebuilding, which were carried out by KOFF last year in collaboration with the American NGO CDA Collaborative Learning Projects. A second expert retreat was

also held in Bern in October 2015 involving 14 organizations from the "community". The survey and the retreat provided clear confirmation that there is interest in a CSC-Hub which combines discourse, learning and information and is coordinated and run by a secretariat. The next step now is to secure the funding required for this.

KOFF led the CSC-Hub initiative until the end of 2015 before relinquishing the leadership at the start of 2016. Until external financing is obtained for the secretariat, the members of the working group will coordinate the hub on an alternating basis.

## 5. 2015: A Pivotal Year in Myanmar

2015 has been a pivotal year in Myanmar. Aung San Suu Kyi's National League for Democracy (NLD) has won a landslide victory after general elections on 8 November. It was the country's first national vote since a civilian government was introduced in 2011, ending nearly 50 years of military rule. In parallel, after more than two years of intense negotiations, the government of Myanmar and eight out of a 15-member coalition of diverse ethnic armed organizations signed a historic ceasefire agreement on 15 October. With several key groups declining to sign the agreement amidst ongoing fighting in the country's border areas, the ceasefire agreement is not truly as 'nationwide' as interlocutors have hoped it would be. Nevertheless, it is an additional step forward on the bumpy road to peace. Another fundamental element to take into consideration to understand the current dynamics in the country is the issue of race and religion between Muslims and Buddhists, which crystallizes in communal violence, as well as the dire politics of Rakhine State that could destabilize the country's democratic transition.

National actors involved in these processes are under an enormous amount of pressure: pressure to push these processes forward into new phases; to retain Myanmar's international image abroad as a former pariah state joining the international community; and simply put, pressure for a

peaceful and prosperous future. While Myanmar's peace process has been uniquely homegrown and nationally driven, the influx of international peacebuilders offering support and advice to national actors has also added to this pressure. In this critical point in time, international actors should reflect and ensure that their presence leaves space for national actors to remain in the driving seat of these processes, no matter the outcome.

The extraordinary speed at which these transitions from a military to a civilian government, from armed conflict towards peace are unfolding also adds to this pressure. International actors should take into account that even with a ceasefire agreement in place, many deep grievances remain unaddressed and key issues are not yet included in the agreement. A long road towards implementation and political dialogue lies ahead. Similarly, how the new government will fare remains difficult to anticipate.

In 2015, KOFF accompanied these processes by offering a platform to exchange views and analysis on the recent developments. It has also fostered interactions between actors in Myanmar and in Switzerland. For instance, participants in KOFF roundtables explored how national and international peacebuilders can work during a transitional year; how elections are affecting peace processes and how to protect space for building peace in a changing political environment. These questions, and many more, will continue to fuel the debate at future roundtables organized by KOFF.





## 6. Communication

2015 allowed KOFF to increase its presence and visibility, not only among its member organizations and the Swiss public, but also abroad.

Firstly, KOFF used its strategy process to strengthen its presence and its role among its member organizations. The three consultation meetings in Geneva, Bern and Zurich in April and May 2015 allowed KOFF to provide the member organizations with more detailed information about its role and activities, to strengthen the ties between the various organizations, to revitalize the network, to create a sense of "ownership", and lastly to get a feel for the current trends and issues in peacebuilding.

These included the will to make peacebuilding more visible in Switzerland and to discuss the opportunity to strengthen the strategic cooperation between the various entities of the Swiss administration and the civil society in the areas of peacebuilding, fragility and development. KOFF launched the



discussion via its newsletter, which now has over 8,000 subscribers, in the issue on Switzerland's peace architecture published in June. The discussion continued at the annual meeting of KOFF members, also held in June, which brought together many of the interested parties. The conversation was further fuelled


KOFF also created an informative flyer in 2015 that clearly

and succinctly outlines KOFF's mission, its structure, its areas of expertise and the services it offers to its members. This flyer, published in English, allowed KOFF to strengthen its position and visibility not only in Switzerland but also abroad, where KOFF is looking to enhance cooperation with its international partners. KOFF will update the flyer with 2016 developments shortly.

Lastly, KOFF employees attended the meeting of the German FriEnt network in January 2015. The teams used this experience to learn more about and discuss current challenges involved in peacebuilding, networking and possible thematic parallels. KOFF also became a member of the Civil Society Platform for Peacebuilding and Statebuilding (CSPPS), a South-North non-governmental coalition of peacebuilding organizations that coordinates and supports civil society participation in the International Dialogue on Peacebuilding and Statebuilding (IDPS).

All of these initiatives contributed to making KOFF's peacebuilding activities stronger, more relevant and more visible during 2015, and ultimately aim to influence national and international peace policy.
