Women Human Rights Defenders – Activism in Conflict and Post-Conflict Settings

Each year, the Martin Ennals Award rewards human rights defenders from around the world who distinguish themselves by their strong commitment to promoting human rights - often at the risk of their own lives. In 2020, for the first time the Jury nominated three women who defend the fundamental rights of their communities in sensitive contexts.

Within the framework of this KOFF roundtable, two Martin Ennals finalists will share insights into their work and the challenges they encounter as women who defend human rights. While their causes are different, violent conflicts in both settings have shaped their activism. Their status as women, likewise, has proven both an advantage and a liability in advocating for human rights in patriarchal societies.

Ms. Huda Al-Sarari has investigated, exposed, and challenged a network of secret prisons run by foreign governments in Yemen since 2015, where thousands of men and boys suffered arbitrary detention and torture. By collecting evidence and bringing forced disappearances to public attention, Huda contributed to the documentation of human rights violations during the conflict.

Ms. Sizani Ngubane began her activism during South Africa's struggle to end apartheid. She founded the Rural Women's Movement, a unique organization striving against gender-based violence and for women's access to land, education, land rights, property, and inheritance rights in courts operating under customary law.

Following two individual conversations with each of the defenders, the KOFF Roundtable will provide space for an open discussion and reflection on the experiences of woman human rights defenders. What are challenges of conflict and post-conflict settings for human rights? How can human rights activism in conflict and post-conflict settings inform peacebuilding? What are common challenges that women human rights defenders face, and how to address them? To what extent does a gender dimension inform human rights work? What role can Switzerland play in supporting women human rights defenders in conflict and post-conflict settings?
